#### How to use

- Before use, carefully read the directions on the packaging and act accordingly.
- Remove loose old lacquer and rust and sand the surface.
- The surface should be clean, dry and free of grease. The can should have room temperature. Best processing temperature 15 to 25°C.
- Before use, shake the can. Working pressure 4 to 5 bar.
- Apply the Stone Chip Spray in the desired layer thickness. After drying, without sanding, re-sprayable with all lacquer systems.
- After use, clean the spray-gun with white spirit
- The drying time depends on the ambient temperature, the humidity of the air and the thickness of the lacquer applied.
