DESCRIPTION AND KEY PROPERTIES

Concentrated product for manual cleaning of windscreens from insects and atmosphere dirt. It cleans difficult dirt without causing damage to seals. Leaves no haze and speckles and gives perfect visibility. Is used on every glass surface.

DOSAGE AND USE

Product is ready to use. Do not dilute. Spray with a common trigger spray 4-6 times all over the windshield surface.

- <u>Ratio of ingredients in use</u>: 3-5ml of the cleaner covers the whole front windshield surface. 15-16 ml cleans all the glass surfaces of one car.
- Min process temperature: 5° C
- Max process temperature: 30°C
- <u>Conditions to avoid and possibility of hazardous reactions</u>: Contains ethanol, keep the packaging closed. The product is stable in proposed normal use conditions.

Do not mix with other chemicals. Do not transfer the product to containers of unknown specifications.

PACKAGING AND STORAGE

Packing material: polyethylene cans 20L.

Dimensions of cans- 26,5 cm x 21cm x 38 cm (20L)

Dimensions of europallet- 20L 0,8m x 1,20m x 0,9 m (h)

Item weight - 20,8 kg (20L)

Europallet weight (24 x 20L) = 522 kg

Shelf life: 3 years from production date in sealed packaging (production date is written as lot number on label or can).

<u>Conditions to maintain shelf life</u>: Check min and max storage temperatures: 5 °C – 30 °C and store away from solar radiation in a shady place and well-ventilated place. Keep container tightly closed.

The product is stable under the proposed storage conditions.
